Housing & Supportive Services - 140 youth accessed housing case management services, and the Center successfully housing 37 young people who were previously houseless. The Center's Life Essentials Closet was accessed 289 times, 245 meals were provided, and youth received over \$42,000 in direct financial assistance.

Youth & Community Programs Youth Programs served a total of 1,477 unduplicated youth through drop-in space, virtual space, and youth facing events. Time Out Youth saw 236 new youth in 2024, and expanded its offerings to include more identity-specific programming. 2,967 people were reached through trainings, presentations, and community events.
